This requirement does not apply to applicants who have completed comparable orientation in another association, provided that REALTOR® (Appraiser) membership has been continuous, or that any break in membership is for one year or less. Failure to satisfy the Ethics Requirement within 90 days will result in denial of membership application and termination of provisional membership. I further agree that my act of paying dues shall evidence my commitment to abide by the aforementioned Code of Ethics, Bylaws, Rules and Regulations, and duty to arbitrate, all as from time to time amended. Finally, I consent that and authorize the above Association to invite and receive information and comment about me from any member or other persons, and I agree that any information furnished to said Association by any member or other person in response to any such initiation shall be conclusively privileged and not form the basis of any action by me for slander, liable or defamation of character.

NOTE: Applicant acknowledges that if accepted as a Member and he/she subsequently resigns or is expelled from membership with an ethics complaint or arbitration request pending, the Board of Directors may condition renewal of membership upon applicant's verification that he/she will submit to the pending ethics or arbitration proceeding and will abide by the decision of the hearing panel; or, if applicant resigns or is expelled from membership without having complied with an award in arbitration, the Board of Directors may condition the renewal of his/her payment of the award, plus any costs that have previously been established as fee and payable in relation thereto, provided that the Award and such costs have not, in the interim, been otherwise satisfied.
